



Assembly Instructions

Step 1: Cut conductive cables to desired length using cable cutters, not wire cutters or diagonal cutters. Failure to use cable cutters will result in the inner conductive cable not being cut cleanly. Note the cable will be inserted into the grippers. See OAH Chart for reference while determining the cut length.

Step 2: Connect conductive cable to the canopy. Use the included practice section of the coax conductive cable until you feel confident installing the cable.



- A. Mark the conductive cable 1-1/8" from both ends.
- B. Unscrew the Cap from the cable gripper and slide it over the conductive cable.
- C. Cut the outer sheathing and insulator with a **16 Ga. Wire stripper**. Open the stripper, rotate 90° and repeat until sheathing is completely cut.
- D. Strip the wire by wrapping the cable around your hand and using a 14 Ga. Wire Stripper.
- E. Flare out the outer braided sheathing so that it will lay on the outside of the nipple on the cable gripper
- F. Insert the cable into the gripper until it bottoms out. The insulator will go into the gripper while the outer sheathing will lay over the outside of it.
- G. Secure the cap back onto the gripper. Be careful when tightening the cap not to cut the outer sheathing.
- H. Smooth out sheathing by pinching the cable and pulling away from the gripper.


NOTE: Cable can be released from gripper by unscrewing the threaded nipple under the cap and depressing the plunger while pulling on the cable.

Step 3: Mount Canopy by first removing the Cover Plate, unscrew the flat head screws (QTY:2). Mount to ceiling with included hardware pack according to the provided hardware pack instructions. Make wire connections to source power and replace cover plate.

Step 4: Verify cables are all the right height. Then repeat step 2 to mount the light body's to the conductive cable. Light bodies should hang at the same height, adjust if needed

Step 5: Install glass panels onto light bodies.

- A.Place one silicon washer on each cylinder knob with all thread
- B. Attach the all thread to the glass panels, by inserting them through the holes in the glass and inserting a second silicon washer onto the all thread . NOTE: Cylinder knob must be the outside surface of the glass. (Smooth on granite. Textured on Rimelight)
- C.Install glass onto light bodies. Align all thread with mounting brackets and tighten the all thread.



Note: The Phillips head screws shown in the above image are used to tighten/loosen the glass mounting brackets.




